Iola ISD Parental Involvement Policy

PART I. GENERAL EXPECTATIONS

- Iola ISD agrees to implement the following statutory requirements:

 - > Ensure character Education is taught
 - B. Iola ISD will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

- Offer training on the computer based instructional programs utilized at the school
- Conduct make & take parent training sessions
- C. Iola ISD will, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
 - Conducting annual training on the value and importance of parents in the educational process
- D. Iola ISD will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
 - ➤ Offer teachers in outside agencies located within the district boundaries to participate in district training
- E. Iola ISD will take the following actions to ensure that information related to the school and parent- programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
 - > Information will be posted on the website
 - District level communication will be sent through the Superintendent's office
